

## TERMS AND CONDITIONS – Easter Hamper Giveaway

1. Information on how to enter form part of these Terms and Conditions. Entry into this Competition is deemed to be an acceptance of these Terms and Conditions.
2. The Competition commences at 5pm Monday 7<sup>th</sup> April 2025 (AEST) and concludes at 11.59pm on Wednesday 16<sup>th</sup> April 2025 (AEST) ('Competition Period').
3. The Competition is open to Australian residents who are 18 years of age or older as of the beginning of the Competition Period, who are not an employee of the Promoter or any of its affiliated companies, their advertising or promotional agencies.
